

3. Elizabeth McCabe --"my beloved companion"

- testator's son John to pay her the annual sum of \$12.00 for her natural life
- Amos to pay her the annual sum of \$12.00 for her natural life
- to have the testator's household furniture consisting of beds, bed clothing, carpets, cupboard ware, stools, chairs, tables, bureaus, and all appertaining along with all the testator's hogs, sty, corn and meat that may be on hand at the testator's death

4. Amos McCabe --son

- to have the farm on which he now lives being the same left the testator by his father or so much thereof that lies contiguous upon the southerly and westerly side of the state road leading to St. Martin's --to have on condition

5. Patience Long --daughter (wife of Zeno Long)

- testator's son Amos to pay her the sum of \$175.00 clear of interest within 2 years after the testator's death

6. Susan Murry --daughter (wife of Joshua Murry)

- to have the place or farm called "The Lot Field" in Worcester County, Maryland with all improvements belonging and no more of the estate either real or personal provided that Joshua Murray pays the testator's wife the annual sum of \$6.00 for her natural life

7. Charlotte Collins --daughter (wife of Elisha Collins)

- to have the sum of \$1.00 and no more of the estate both real and personal

8. William McCabe --son

- to have all the estate left to the testator's widow at her death provided he sees to her affairs and takes special care of her during her life
- to have all the land lying contiguous on the easterly side of the state road being the same land on which the testator now lives and also to have all the goods, merchandise, etc. belonging to the testator's store provided he pays and discharges all the testator's debts and expenses
- named executor of the will

Then came: Elisha M. McCabe

Note: the testator signed the will in his own hand

Note: letters of administration were granted to William McCabe who gave bond with Amos McCabe, security in the sum of \$2000.00

- to have Negro woman "Rachel"

2. Phillip Rodney Marvel --son

George Edward Marvel --son

- to have all the rest and residue of the estate to be divided between them

3. William Messick --brother

- testatrix desires that he and her sister Sarah T. Messick to have all the estate to be divided between them should both of the testatrix's sons die without issue.

-named executor of the will

Jane S. Carpenter

Then came: Aaron Marvel

Note: the testatrix signed the will in her own hand

Note: letters of administration were granted to Minos Messick who gave bond with John West, security in the sum of \$600.00
