Folio 339 **POLLY BURTON, of Angola, Indian River Hundred** 04/13/1857

Bequeaths to:

1. Henry H. Burton

-to have all the real and personal estate of whatever kind to hold in trust for the purposes listed below--to pay out of the personal estate all the testatrix's debts and expenses and to hold all the real estate and islands in Herring Creek devised to the testatrix by her husband James Burton, deceased in his last will and testament

2. Sarah P. Burton --wife of John Hambleton Burton

-to have the use of the residue of the lands and personal estate held in trust by Henry H. Burton clear and free from any claim or demand of her husband and after her death, the whole of the residue of the estate to be for the children of the said Sarah

Witnesses: Manan B. Marvel
John B. Hazzard

Then came: Manan B. Marvel

Note: the testatrix signed the will with her mark

Note: letters of administration were granted to John Hamilton Burton who gave bond with Zadock Milby and Wesley W. Stephenson as securities in the sum of \$500.00

Folio 341 **PETER HOLLAND, of Lewes & Rehoboth Hundred** 03/13/1857 04/21/1857

Bequeaths to:

1. Comfort B. Holland --wife

-to have all the testator's real estate during her natural life

Note: letters of administration were granted to Comfort B. Holland who gave bond with William A. Dodd security in the sum of \$5000.00

Folio 342 **GARRISON McCABE, of Baltimore Hundred** 01/22/1857 04/27/1857

"being of good health of body . . ."

Bequeaths to:

1. John McCabe --son

-to have all the land and farm he now occupies which the testator purchased from Isaac McCabe with all improvements, etc. belonging on condition

2. Elizabeth Hudson --daughter (wife of Nathaniel Hudson)

-testator's son John to pay her the sum of \$175.00 within 2 years after the testator's death without interest
