To daughter Sarah Callaway - one shilling

To daughter Isabel Taylor - one shilling

To daughter Esther Taylor - one shilling

8 August 1792 Then came

Daniel Vinson, planter being in perfect health

27 December 1783

To son Charles Vinson that I had by Elizabeth Gullet the widow of William Gullet - 15 pounds to be paid by my son Newbold Vinson when Charles comes to age

To son Newbold Vinson that I had by Elizabeth Gullet the widow of William Gullet - 50 acres of land that I now live on and half of movable estate

To wife Elizabeth Gullett or Vinson the widow of William Gullet - use of all estate during her lifetime or widowhood

Executor: my wife Elizabeth Vinson or by some called Elizabeth Gullet the widow of William

Witness: Obadiah Marvel, Shiles Moor, Jesse Baker

8 August 1792 Then came Obadiah Marvel, Shiles Moor

Absalom Cannon

27 May 1792

To wife Frances - my dwelling plantation with all my movable estate for her natural life

To son Joseph Cannon - plantation after wife's decease

To son Isaac Cannon - plantation if son Joseph dies without heir. Also colt and bed and furniture and cow and calf

To son Edward Cannon - plantation if Isaac dies without lawful heir. Also 45 acres of my land whereon he now lives to be laid off on the south side of my dwelling plantation

To children Tamsey Vincent, Edward Cannon, Catherine Coleburne, Sarah Cannon, Clare Jones, Priscilla Vincent, Isaac Cannon, Frances Patchett, Joseph Cannon - movable estate after wife's death

Executor: son Isaac

Witness: Robert Clarkson, Joseph Cannon, Levi Cannon

2 October 1792 Then came

Bathsheba Miller

3 June 1790

To son Peter White - Negroes Isaac and Shadrach. Also the residue of estate after debts are paid and a head and foot stone purchased for my grave

To daughter Jenny Richards - Negro woman named Nance and Nance's children Ishmael, Pat and Hagar. Also feather bed that has the white ticking, 2 pair of sheets, walnut dining table and 6 pounds

To daughter Mary Perkins - Negro woman Phillis and her son Abraham. Also 6 cattle, large walnut table, feather bed, 2 sheets, carpet, 6 pounds in cash and my large Bible
