 To son Edmund Knowles - one shilling
 To daughter Abigale Ellis (wife of Joshua Ellis) - one shilling
 To son Ephram Knowles - remainder of saw mill on Cod Creek. Also 50 acres of land where the saw mill stands taken up in the year of seventy six and to include his dwelling house and plantation as also my dwelling house and plantation whereon I now live being the remainder of Knowles Venture to extend as far as the lines I sold Joshua Moore or has been laid off to the said Moore. "as also my still as she stands"
 To daughter Prudence Knowles - bed and furniture that always was called hers and cow and calf, red chest and 5 pounds

To wife Mary - for her lifetime one third of my lands and movable estate. Also Negro man named Peter and woman named Beck
 To son John Rickards - the manor plantation by patent called anton Green. Also part of a tract called Rickards Chance and also a resurvey (surveyed by Joshua Robinson) adjoining the said land. Also one British musket and all my wearing apparel and one chest
 To son William Rickards - a plantation in the forest which by patent is called Rickards Choice. Also a resurvey that I took up. All my part except what I took up for Job Derickson. Also small gun and one chest
 To son Luke Rickards - all my lands in the big neck being part of a patent called Cow Quarter and also part of a tract called Fair Haven. Also one musket
 To Job Dirickson - all my right to part of a resurvey to a tract that was surveyed to Rickards's Choice. Which part to be divided beginning at Job's boulder and he to have that which is south and east of the boulder
 To daughter Hannah Rickards - a Negro boy named Bob. Also bed and furniture, chest and spinning wheel
 To daughter Betty Rickards - Negro boy named Newport. Also bed and furniture and chest
 To daughter Margaret Rickards - Negro girl Omy to be sold and the money put to interest until Margaret is of age. Also the sum of 10 pounds
 To my six children - remainder of estate
 Executor: my brother John Rickards and my wife Mary

To son Joseph Ward - 50 acres of patented lands called Callaway's Neglect and 100 acres of warrant land being part of my resurvey. Also all my coopers tools
 To son Moses Ward - 50 acres of patented land being part of tract Winter Range and where I now live. His part to be laid off on the north end. Also 100 acres of warrant land being part of my resurvey. If Moses should die without heir, this to my son John
 To son John Ward - remainder of Winter Range and 100 acres of warrant land and half my share of a saw mill and half of that land that I bought of Elijah Hall and one hand mill
