To Polly (the daughter of my wife whom I acknowledge to be my child) - the use and benefit of my lands and farm and bed and furniture, mare called Fance and half of farming utensils

To son Giddaddiah Hall - the estate given to my wife after her death and "if ever he comes for it"

To Job Dirickson (son of William Dirickson deceased) - yoke of oxen when he is of full age

To wife and daughter Polly - remainder of estate with Polly's part delivered at the time of marriage. If Polly should die, her part to remain with my wife

To wife Director Harris - for her lifetime, cow and calf, yoke of oxen, half of sheep, 7 hogs, 3 feather beds, 2 tables, cupboard, chest, all plate and pewter and Negro boy Levin until Levin is 25 years old

To son Abraham Harris - half of sheep

To son Benton Harris - 5 shillings

To "my son Peter Parker" - 5 shillings and the service of the said Negro boy after my wife's decease (in case she should die before Levin is 25 years old). Also bed and furniture

To daughter Elizabeth Mitchel - 5 shillings

To daughter Scarber Jones - 5 shillings

To grandson Benton Marvel - lot of ground joining John Prettyman's called Persimmon Lot

To son Peter Parker and daughter Scarber - that given to wife after her decease

To the children of my daughter Prisila Marvel - each 5 shillings
