1 May 1793

To Jesse Cannon (son of my brother Jesse) - Negro boy named Peter

To Mathew Cannon (son of my brother Jesse) - Negro girl named Lott and half of all my land. That is to say the lands that I inherited from my brother Jesse and my part of the tract called Three Brothers as well as the land devised me by my father to be laid off for him on the east side of the house where I live. Also the free use of half of the orchard for a term of ten years

To Levin Cannon (son of brother Jesse) - remaining half of the land as above mentioned in the devise to Mathew. The land to be the division line and includes my dwelling house and the part of the plantation on the west side of the lane. Also Negro man Lazarus

To Milley (daughter of brother Jesse) - Negro woman Leah

To the four children of my brother Jesse - remainder of estate

To the children of my brother Levin - all my right title and claim to the lands which their father died possessed of

Phillip Marvel Senior, planter of Dagsbury Hundred

4 May 1795

To son Phillip Marvel - all that tract on which I now reside with all the other adjacent tracts which I have taken up in my own right (excluding that given to my wife). Also yoke of oxen that he usually calls his. That if my wife should die or marry before Phillip is 18 years old, he should enjoy the lands bequeathed to him at that age

To wife Comfort - for life or widowhood, the free enjoyment of all house, buildings and orchards and the use of such part of the plantation as she may think proper to till and have the liberty to cut the timber of the wood land. Also the use of Negro girl Sue for her lifetime and after wife's death, Sue to be the property of my daughters Mary and Chloe. Also residue of personal estate

To son Thomas Marvel - 5 shillings and no more

To son William Marvel - 5 shillings and no more

To son Aaron Marvel - 5 shillings and no more

To daughter Rhoda Butcher - 5 shillings and no more

To children Adam Marvel, David Marvel, Mary Marvel and Chloe Marvel - personal estate after wife's death
