She grew to womanhood on the home farm, attending school, helping with the home duties, which naturally were many in so large a family; and being loved and teased by her crowd of big brothers. She was converted and joined the Methodist Church in her early years, and throughout her life has been active in Church work, and in temperance and philanthropic work. A drunken doctor gave her the wrong medicine for some child's illness when she was very young, which nearly cost her her life, and did permanently impair her health. (No wonder she is in W. C. T. U. work.) She has been honored with a medal in W. C. T. U. work, and is an associate of Mrs. Haney, of Stewart, Florida, who is nationally known in the work of the Woman's Christian Temperance Union. On December 17, 1891, Ida A. Marvel was married to Frank Samuel and they went to housekeeping in the little town of Hallsville, Illinois, where Mr. Samuel was in the business of grain buying and also Pastmaster. At the present time he owns a telephone plant near Danville, Illinois. Their home is at Boswell, Indiana, but for several years they have been spending the winters at Miama, Florida, (774 N. - Charles R. and Mary (Marvel) Smith was born in DeWitt County, Illinois, December 5, 1873. She grew to womanhood on the home farm, and September 21, 1898, was married to Thomas Odell Brown, who was born in DeWitt County, Illinois, September 6, 1869. They made their home in Clinton, Illinois, until after the death of Mr. Brown, who passed away October 29, 1917, at the age of forty-eight. For over fifteen years prior to his death he had been a dry goods merchant. In 1921 Nellie B. (Smith) Brown and family moved to Oregon and later Mrs. Brown moved to California. Thomas O. and Nellie B. (Smith) Brown were the parents of three sons:
- a. Wilfrid Odell Brown, oldest child of Thomas O. and Nellie B. (Smith) Brown, was born in Clinton, Illinois, August 24, 1900. He was married July 20, 1920, to Beulah Rosenberg, of Galesburg, Illinois. - III. Levina Marvel, third child of Wiley and Charity (Clark) Marvel, was born in Gibson County, Indiana, January 17, 1832, and died October 14, 1833.
- IV. Elizabeth Marvel, fourth child of Wiley and Charity (Clark) Marvel, was born August 24, 1834, in Gibson County, Indiana, and died September 18, 1834.

V. Prettyman Marvel, fifth child and second son of Wiley and Charity (Clark) Marvel, was born in Gibson County, Indiana, December 29 1925. His early years were spent in the parental home in Southern Indiana, engaged in occupations incident to the lives of pioneer's children, in the winter months attending such schools as the time afforded. At the age of fifteen he entered Asbury Academy at Greencastle, Indiana (now DePauw University), where he remained for two years. In the year 1852 he came with the family to De-Witt County, Illinois, where being the oldest of the children then at home, he continued with his father on the new farm home until his marriage. In April, 1859, Prettyman joined a company of twentyfive young men, which, with Thomas Bergen at their head, was organized for the purpose of making a trip to Pike's Peak to search for gold, there being considerable excitement over a reported discovery of the precious metal in that region of the Rocky Mountains. Six of the company were from the vicinity of Waynesville: Richard Botkin, Elijah Coleman, Prettyman Barr, another Prettyman Marvel (a cousin, son of Prettyman Marvel, Jr., see page 170 of this history), besides "Uncle Wiley's" two boys, Prettyman and Joseph. The six took three ox teams of four exens each with covered wagons loaded with supplies of cured meat, flour, corn meal, and dried The men walked driving their oxen. Crossing the Missouri River at St. Joe, where they joined the rest of the company thence traveling westward to the Big Blue River in Kansas, struck northwestward until they reached the valley of the Platte, which they followed to the mountains. Their dream of gold proved a delusion, but it was a great trip, the varied experiences of which Prettyman never tired of telling.

Prettyman Marvel was married on November 18, 1859, to Ellen Jane Kenton, a near relative of Simon Kenton, the noted pioneer. She was born November 18, 1944. After seven years of married life she passed away, leaving two small children. Mr. Marvel was married a second time in 1867 to Mary Judith Jones, daughter of William and Nancy (Bay) Jones.

In March, 1871, Mr. Marvel, in company with a brother-in-law, George W. Duncan, moved with his family to Kansas, settling near Westmoreland. There he improved a good farm, and in the autumn of 1889 moved to Baldwin, Kansas, having in view better educational advantages for his children, as Baldwin was and is, the seat of Baker University. He lived there until his death, which occurred July 12, 1912, after a protracted illness. Mrs. Marvel died March 24, 1906.

Prettyman Marvel was a public spirited citizen, active in all movements looking toward the betterment of the community where he lived. He represented his County (Pottawatomie) in the Kansas 266

legislature in 1875-'76, and was again the republican candidate for representative in 1882, but was defeated by a narrow margin by reaction of the reaction against Prohibition, which the state had adopted two years before; and Mr. Marvel was a staunch probitionist. He was County Commissioner in 1877-79, and most of his mature life a member of the School Board. He was a life-long Methodist, taking a leading part in pioneer Church work in Kansas, being Recording Steward, Trustee, and Superintendent of Sunday School for many years. The building of the little country church at Pleasant Run, near his home, in 1883, was largely due to his efforts; and to this day that Church has never abandoned its services. He loved rightecusness and hated iniquity.

Prettyman Marvel was the father of ten children, as follows:

- 1. Mary Ellen Marvel, oldest child of Prettyman and Ellen J. (Kenton) Marvel, was born at Midland City, Illinois, December 22, 1860. She was married at her father's home near Westmoreland, Kansas, in June, 1884, to Otto Gier, son of Frederick and Gier. Two sons were born to them, as follows:
- a. Walter Roy Gier, oldest child of Otto and Mary E. (Marvel) Gier, was born at Fostoria, Kansas, Steptember 17, 1891. He was married to Frieda Marie Berkec'al, at Napa, California, January 20, 1924. Mrs. Gier was born at Hamburg, Germany, November 4, 1892. They have one daughter, Lois Marie Gier, born October 31, 1924. They live at 3249 Liese Avenue, Oakland, California, where Mr. Gier is a city mail carrier. Mr. and Mrs. Gier are active workers in the Baptist Church in their local community.
  - b. Arthur Dewey Gier, second child of Otto and Mary E. (Marvel) Gier, was born at Morse, Kansas, May 16, 1898. Arthur is at present in the U.S. Navy.

Mrs. Mary E. (Marvel) Gier died at Pueblo, Colorado, February 23, 1923. Otto Gier lives at Oakland, California.

2. Ulysses Grant Marvel, second child of Prettyman and Ellen J. (Kenton) Marvel, was born near Midland City, Illinois, September 6, 1863. He attended the public schools there and in Pottawatomie County, Kansas, whither the family moved in 1871. He entered the service of the Central Branch Railroad (now the Missouri Pacific) at Atchison, Kansas, about 1884, and except for a short time on a farm in Missouri, has been in the railway service ever since. He is now a conductor on the Colorado and Southern Railway out of Denver. He was married in 1887 to Charlotte Pringle, of Dallas, Texas. Their home is at 4042 Alcott Street, Denver, Colorado. They are the parents of twelve children, of whom three died in childhood. A complete record of the children of U. G. and

Charlotte (Pringle) Marvel has not been obtainable, but the following is a partial record: Charles, Annie Dolores, James Riley, Grant Wiley, Harold, Cornelia Imogene (is married and living in Pueblo, Colorado), Netta (married Patrick O'Connell and lives in Pueblo, Colorado. They have three children, Donald, George and ); George, Ena and Helen.

The U. G. Marvel family are members of the Roman Catholic Church.

The children of Prettyman Marvel and Mary Judith (Jones) Marvel are as follows:

- 1. Unnamed infant, died at birth.
- Esther Almira Marvel, second child of Prettyman Mary J. (Jones) Marvel, was born at Midland City, Illinois, December 18, 1869. Her parents moving to Kansas when Esther was quite young, she was educated in the public schools of the latter state, teaching in the country schools after finishing the district school. In the autumn of 1889 she entered Baker University, at Baldwin, Kansas, graduating in 1895. She afterwards taught school for several years. In September, 1900, just before beginning her work as teacher in a college at Alvin, Texas, she was caught in the terrible storm that wrought such havoc at Galveston, and narrowly escaped with her life. Her health was permanently impaired by this experience. On June 25, 1901, she was married to Charles Benjamin Dalton, son of the Rev. Henry Dalton, a native of England. Mr. Dalton was a young Methodist minister at the time of their marriage. He has held pastorates in Kansas City, Kansas; El Paso, Texas; Boise, Idaho; and Berkeley, Sacramento, Pomona, Santa Barbara, San Bernardino, Orange, Pasadena, and Redondo Beach, in Cali-Esther (Marvel) Dalton died in Berkeley, California, on September 21, 1910. They were the parents of two children:
- a. Evelyn Ruth Dalton, oldest child of Charles B. and Esther (Marvel) Dalton, was born in Kansas City, Kansas, June 20, 1902. She graduated from the Pasadena, California, High School in 1919, and from the University of California in 1923, receiving her Master's degree from the same institution in 1924. She is at present teaching in the Ukiah, California, High School.
- b. Esther Frances Dalton, second child of Charles B. and Esther (Marvel) Dalton, was born in Boise, Idaho, January 28, 1907. She graduated from the High School at Orange, California, in 1923 and from Redlands University in 1928. She is an accomplished musician and lives at home in Redondo Beach, California.







- Mary J. (Jones) Marvel, was born near Westmoreland, Kansas, October 8, 1871, on the farm afterwards owned by his uncle, George W. Marvel. He attended the district school near by, and in 1899 entered Baker University at Baldwin, Kansas, graduating in 1894. Afterwards he taught school for three years, then entered the ministry of the Methodist Episcopal Church, taking a theological course at Boston University School of Theology, from which he graduated in 1901. He has held pastorates at the following places: Dunavant, Centropolis, Kansas City, Wamego, Topeka, Clay Center, White City, Valley Falls, Burrton, Oxford, and Argonia, in Kansas; and in Douglas, Arizona. He is at present pastor at Argonia, Kansas. He was married on August 30, 1904, at Kansas City, Kansas, to Katie May Rushmore, daughter of Henry C. and Martha (Landon) Rushmore. They are the parents of five children, as follows:
- a. Theodore Prettyman Marvel, oldest child of George A. and Katie (Rushmore) Marvel, was born at Wamego, Kansas, July 15, 1905. He graduated from the High School at White City, Kansas, in 1921, was for two years in school at Southwestern College, at Winfield, Kansas, three seasons in Chautauqua and Lyceum work as reader and baritone singer, studied Voice in New York City for a year, and is at present in school at Chicago University.
- b. Helen Margaret Marvel, second child of George A. and Katie (Rushmore) Marvel, was born at Wamego, Kansas, May 6, 1907. - VI. Joseph Wiley Marvel, sixth child of Wiley and Charity (Clark) Marvel, was born in Gibson County, Indiana, July 30, 1838. When Joseph was fourteen years old the family moved to DeWitt County, Illinois, settling on the farm on which the father lived until

his death. Here the boy lived and worked with his brothers to build a home in the new country, and make life worth while on the Illinois prairies. Illinois had enjoyed statehood for a generation, yet settlement was made slowly, and much of the state was still virgin soil. In April, 1859, Joseph joined a company of young men who dreamed of a fortune by digging gold at Pike's Peak and started by oxteam across the Plains. In the company also were Joseph's brother Prettyman, and two of his cousins, Prettyman Marvel, and Prettyman Barr, and twenty-one others—twenty-five in all. Their quest for gold was fruitless, and they returned home in the fall of the same year.

Early in the following spring, March 18, 1860, to be exact, Joseph Marvel was married to Nancy Emmaline Barr, daughter of Thomas and Alcy (Watt) Barr. They began housekeeping on a quarter section in Logan County, which he purchased from the Government. Later he bought an adjoining eighty acres, and by diligence and care in improving the place made it one of the finest farms in that section of the country. Both Mr. and Mrs. Marvel were Methodists, and active workers in the "Old Tabor Church." In 1901, they purchased a home in Waynesville, retired from the farm, and spent the remainder of their lives in that village. They were both interested in all religious enterprises, and active supporters of the Waynesville Methodist Church of which they were members. Mr. Marvel was tall and rather spare in build, and of a quiet disposition, but he was a firm believer in the right and was a friend to every one. He was usually a democrat in politics. He and his older brother Prettyman were much alike in appearance and being of nearly the same age, were great chums as boys and very close to each other as men. He passed away at his home in Waynesville, October 7, 1909. Mrs. Marvel followed him in death on August 20, 1916.
