THE SONS AND DAUGHTERS OF PRETTYMAN MARVEL SR.

—GEORGE ROGERS MARVEL—

Part IX

George Rogers Marvel the ninth and youngest child of Prettyman and Lavina (Rogers) Marvel, was born in Gibson County, Indiana, March 8, 1815. He was married August 13, 1834 to Sarah H. McReynolds, the daughter of Edward and Sarah (Anderson) McReynolds. Sarah (McReynolds) Marvel was born in Wilson County, Tennessee, April 27, 1820.

Being the youngest child, it fell to the lot of George R. to care for his parents. So he and his wife remained at the old Marvel homestead until 1849, when he bought a farm of two or three hundred acres in Posey County. This farm was located about five miles from Poseyville, and a little more than that distance from New Harmony, Indiana. He removed here, taking his parents with him and building a small, cmfortable house for them where they remained, receiving very careful attention from George R. and his wife. But the mother, Lavina (Rogers) Marvel, soon died and thereafter Prettyman, Sr., lived in the home of his son, George R. In 1851 George R. Marvel removed to Franklin County, Illinois. He bought what was then called the "Fancy Farm," a tract of five or six hundred acres on which was a large two story house. This was located in Cave Township in the extreme south eastern part of the county about sixteen miles from Benton, the county seat.

At the beginning of the Civil War, he enlisted in Co. C., 31st Ill. Infantry as Veterinary Surgeon, under General John A. Logan. He was a close friend and comrade of General Logan, and through his influence George R. was commissioned a Colonel to raise a thousand men. He came to Cairo, Illinois and took the train for Chicago, stopping at the towns on the road. By the time he came back to Cairo he had enlisted 13,000 men. He organized the 13th Ill. Cavalry, which he led to the front in service for the Union cause. He fought at Belmont, Fort Henry, and Donelson, Shiloh, Corinth, Oxford, Holly Springs, Champion Hill, Black River, Raymond, Vicksburg, and was in numerous skirmishes. He received a flesh wound at Fort Donelson. He became so disabled by rheumatism that he had to be helped on and off his horse. On account of this and of deafness, he resigned as Colonel before the close of the war. Four sons and two son-in-laws of George R. Marvel were with him in the army.

George R. and wife were both members of the Methodist Episcopal Church he having joined when a lad of fourteen years. He was a steward over twenty years. In politics he was a Republican and a strong Abolitionist. He was always a great lover of fine horses and usually had several to exhibit at the County Fairs. Col. George Rogers Marvel died February 16, 1889.

His wife, Sarah H. McReynolds Marvel died June 29, 1901.

George R. and Sarah H. Marvel were the parents of twelve children as follows: Asenath Ellen, Prettyman Wood, John Julian, Wiley Hensley, William Teal, James Edward, Sarah Elizabeth, Lucy Jenett, Lavina Jean, George Hill, Martha Ann, and Hattie May.

- I. Asenath Ellen Marvel, the oldest child of George Rogers and Sarah (McReynolds) Marvel was born December 18, 1836, in Gibson County, Indiana. She was married in 1852 to Jesse Green Mitchell who was born in Franklin County, Ill., February 19, 1833. His father, Sion Hunt Mitchell, was born September 19, 1797, and was a grandson of Lord Hunt of England. Jesse Green Mitchell, at the time of his death, December, 1891, was a merchant, and a main stay in the M. E. Church at Benton, Ill. The children of J. G. Mitchell and Asenath Ellen (Marvel) Mitchell, are as follows: Willis Elmore, Sarah Eizabeth, Thomas Green, John Minton, and Charles Emory.
- 1. Willis Elmore Mitchell, son of J. G. and Asenath Ellen (Marvel) Mitchell, was born in Franklin County, Illinois, July 18, 1854. On April 19, 1877, he was married to Miss Emily McAually, who was born November 7, 1854. Willis Elmore Mitchell was educated in Liberty High School, and Northern Indiana Normal at Valparaiso, Ind. He is a retired merchant and a large land owner and his home is near Texarkana, Ark. Four children were born to Willis E. and Emily E. Mitchell, as follows:
- 1. Daisy Mitchell, born February 6, 1878, died September 30, 1878.
- 2. Jesse Franklin Mitchell, born June 24, 1880, was married to Miss Amy Grace Ingle on January 1, 1899 at Hoopston, Ill. They have two children: Royse Ingle Mitchell, born January 5, 1901; and Jesse Dale Mitchell born November 13, 1906.
- 3. Thomas Elmer Mitchell, born September 20, 1883, died April 6, 1902.
- 4. Daniel Henry Mitchell, son of Willis E. and Emily E. Mitchell, was born Sept. 3, 1887, died Dec. 8, 1895.

- 2. Sarah Elizabeth Mitchell, daughter of J. G. and Asenath Ellen (Marvel) Mitchell, was born in Franklin County, Ill., July 26, 1857. After finishing her education at the Southern Illinois Normal University, she was united in marriage to Dr. P. S. Pope, of Benton, Illinois on November 29, 1877. The living heirs to their union are four:
- 1. Benjamin Willis Pope, born in Benton, Illinois, July 21, 1881. After finishing high school, he was for several years at the head of "The P. S. Pope Co.," General Department Store. At present he is general agent for a large real estate firm in Kansas City, Mo., with headquarters in the city.
- 2. Ellen Eudora Pope was born in Benton, Ill., Aug. 5, 1885. After finishing high school she graduated from Christian College. Columbia, Mo. She continued her musical studies in the Brennan Conservatory of Music, at Gainsville, Ga. She was married in 1910 to George A. Powers, who is a graduate of the University of Illinois. They have one child, George A. Powers Jr., born in Benton, Ill., July 25, 1911.
- 3. Florence Emiline Pope daughter of Dr. and Mrs. P. S. Pope, was born in Benton, Ill., June 10, 1888. After finishing high school, she graduated at "Brennan," Gainsville, Ga., with an A. B. degree, and took normal training at Northern Illinois Normal. She is at present engaged in kindergarten work.
- 4. John Emory Pope was born in Benton, Illinois, June 10, 1888. (Twin to Florence Emiline Pope.) He was educated in fight school and in Mexico Military School Mexico, Missouri. He is a member of the Christian Church and is engaged in the clothing business in Benton, Illinois.
- 3. Thomas Green Mitchell, son of J. G. and Asenath Ellen (Marvel) Mitchell was born in Franklin County, Illinois, January 28, 1860, and was married to Miss Nellie Musgrave on March 2, 1886. Thomas G. Mitchell was educated in Northern Indiana Normal, Valparaiso, Ind. He is a retired merchant and extensive land owner of Eldorado, Illinois. Four children were born to Thomas G. and Nellie (Musgrave) Mitchell, as follows:
 - 1. Edith Augusta, died in infancy.
- 2. William Green Mitchell finished public schools in Eldorado, Illinois and attended St. Charles Military College, St. Charles, Mo. two years. He then took a three year law course at Dixon, Ill., graduating in May, 1913 at the age of twenty-four years. He was elected City Attorney of Eldorado, Illinois, in April, 1913.

- 3. Mary Asenath Mitchell graduated from Dixon Normal College in August, 1911, and now, at the age of twenty-one is taking a special two year course in the Chicago Illinois School of Physical Education and Expression. She will finish in June, 1914.
 - 4. Wayne Russell Mitchell, died in infancy.
- 4. John Minton Mitchell son of J. G. and Asenath Ellen (Marvel) Mitchell, was born at Locust Grove, Franklin County, Illinois, July 16, 1862. He was educated in Public schools, Southern Illinois Normal University, Carbondale, Illinois, and Central Normal College, Danville, Ind. In religion he is a Methodist, and has been a member of three General Conferences. His home is in Mt. Carmel, Illinois, where he is engaged in the banking business. He was married June 1, 1886 to Miss Della Russell, who was born in Mt. Carmel, Ill., March 28, 1864. Della (Russell) Mitchell was educated at McKendree College, Lebanon, Illinois. Three daughters were born to this union:
- 1. Grace Rand Mitchell was born March 9, 1887 at Mt. Carmel, Illinois. She was educated in High School, Hollins College, Hollins, Virginia, and Northwestern University, Evanston, Illinois.
- 2. Florence Russell Mitchell, was born May 28, 1890 at Mt. Carmel, Illinois. She was educated in High School, and graduated from Hollins College, Hollins, Virginia in 1911 with an A. B. degree.
- 3. Elinor Mitchell was born October 14, 1892 at Mt. Carmel, Illinois. She received her education in High School, Hollins College, Hollins, Virginia and Northwestern University Evanston, Illinois.
- 5. Charles Emory Mitchell, son of J. G. and Asenath Ellen (Marvel) Mitchell, was born at Locust Grove, Franklin County, Ill., May 20, 1867. He was educated in Liberty High School and St. Louis Business College. Most of his life has been spent in the mercantile business, but he is at present engaged in the real estate business in Kansas City, Mo. He was married on December 26, 1888 to Daisy Bell Westbrook of Marion, Ill. She was born March 26, 1868. Three children were born to this union:
- 1. Harry Westbrook Mitchell was born at Benton, Ill., March 31, 1890. He was educated in Kansas City schools and Mexico Military School, Mexico, Mo. He is engaged in the banking business in Kansas City, Mo.
- 2. Pauline Mitchell was born in Benton, Illinois on June 18, 1891, and was educated in the schools of Oklahoma City, Okla., and Kansas City, Mo. II. Prettyman Wood Marvel, the second child and eldest son of George R. and Sarah (McReynolds) Marvel, was born in Gibson County, Indiana, on February 15, 1839. In 1861 he was married to Miss Permelia Shepherd, daughter of Isaac Shepherd, a farmer living near Thompsonville, Illinois. The bride was aged sixteen years. After his marriage he enlisted in the Sixth Illniois Cavalry and served through the war.

Prettyman W. and wife made their home on a farm of 91 acres about two miles southwest of West End, Illinois. To them were born twelve children, as follwos: Florinda, Logan, Lewis, Sallie, Cassie, Lillie, Nellie, Bertha, George, Myrtle, Edward and Thomas. Permelia (Shepherd) Marvel was stricken with paralysis about the year 1896 and remained so the rest of her lfie. She died April 5, 1909. She was a member of the Free Will Baptist Church. Prettyman W. Marvel at the age of 75 years is still in good health, and still lives near West End, Illinois. He also is of the Free Will Baptist belief.

- 1. Florinda Marvel, daughter of Prettyman W. and Permelia (Shepherd), was born March 18, 1862. She was married to Jobe Miller, son of Daniel Miller, and they lived on a farm known as the "Fancy Farm." Three children were born to them, namely, Frank, Della, and Jasper. Florinda (Marvel) Miller died July 22, 1890.
- 1. Frank Miller married Miss Nora Watkins, daughter of Milton Watkins, a farmer. To them were born five children.
- 2. Della Miller is still at home with her father, Jobe Miller, near Fairfield, Ill.
- 3. Jasper Miller married Miss Louise Griffith. To them were born two children, namely Marvel Dale and Luther Miller. They make their home near Ardeola, Ill.
- 2. Logan Marvel, the second cihld and oldest son of Prettyman W. and Permelia (Shepherd) Marvel, was born April 7, 1864. He was married to Miss Nora Couger, daughter of William and Emma Couger. To them were born seven childen, Versie being the only one of these to live. After the death of his wife, Nora (Couger) Marvel, he was again mraried to Nellie Watson, daughter of Fiels and Mary Watson. To them were born eight children, namely: Everette, Hattie, Ruth, Charles, Ruby, Maude, Ethel and, Permelia. Ethel died in infancy.

Versie, daughter of Logan and Nora (Couger) Marvel, married Roy Serles, son of William and Clemmie Serles. They have one child, Nora Opal Serles.

- 3. Lewis Marvel, third child of Prettyman W. and Permelia (Shepherd) Marvel, was born November 1,1865. He was married to Miss Maud Mitchell. To them were born seven children, namely: Louise, Mildred, Neva, Helen, Guss Mitchell, Elizabeth and one other. The daughter Mildred, died at the age of one year and twentynine days. Lewis Marvel and family live at Bloomfield, Mo. He is employed as fireman on a train.
- 4. Sallie H., fourth child of Prettyman W. and Permelia (Shepherd) Marvel, was born June 28, 1867. She married Chas. Kelim, son of Alexander and Grenne Kelim. They have thirteen children, as follows:
- 1. Florence Kelim, was born near Rileyville, Illinois, October 10, 1884. She was married to Jerry Brewster of Paris, Texas, on March 23, 1900. Five children were born to this union as follows: Edwin, Perry, Bertha M., Marie, and Goldie. Mr. Brewster is an electrician living at Shawee, Oklahoma.
- 2. Lawrence Kelim was born at Rileyville, Illinois on February 9, 1886. He was married on June 23, 1905 to Miss Maud Baty. To them were born four children: Lawrence, Vernon, Celia, and Ina. They make their home at Shawnee, Oklahoma.
- 3. Lizzie Kelim was born at Kingman, Kansas on January 1, 1887. On December 12, 1905, she was married to Robert Doak of Seminole, Oklahoma. They have four children: Lavelle, Lester, Wanda, and Waneeta.
- 4. Bertha Kelim was born at Kington, Kansas on May 14, 1889. She was married to Grover Rutherford of Shawnee, Oklahoma on July 14, 1906. They have three daughters: Mary, Evelyn, and Josephine.

- 12. Robert F. Kelim was born near Shawnee, Oklahoma on March 7, 1909.
- 13. Earnest H. Kelim was born near Shawnee, Oklahoma on January 23, 1912.
- 5. Cassie Ellen, fifth child of Prettyman W. and Permelia (Shepherd) Marvel, was born February 11, 1869. She was married to George Little. One child was born to them, namely, Richard Little. She and her husband separated, and she was again married to Millege Rose. They reside at Poplar Bluff, Missouri.
- 6. Lillie Ansley, sixth child of Pettyman W. and Permelia (Shepherd) Marvel, was born January 17, 1871. She married Calvin Barrett, son of Peter Barrett. They made their home on a small farm near Rileyville, Illinois. Five children were born to this union, namely, Pearl, Ellis, Flossie, Daisy, and Dennis. Calvin Barrett, the husband, died in December, 1908. Lillie (Marvel) Barrett, was married a second time in 1910 to Richmond Morris, a widower with three children. He is a prosperous farmer.
- 1. Pearl, the oldest child of Calvin and Lillie Barrett, was married to Arvin Garrison, a farmer, living near Galatia, Illinois. They have one child, Delorious Lorene Garrison, born October 28, 1918.
- 2. Ellis, second child of Calvin and Lillie Barrett, died at the age of eight years.
- 3. Flossie, the third child of Calvin and Lillie Barrett, died of consumption at the age of sixteen years.
- 7. Nellie, the seventh child of Prettyman W. and Permelia (Shepherd) Marvel, was born January 15, 1873. She married Vitallis Johnson, son of Harvey Johnson. They made their home about two miles northeast of Thompsonville Illinois on a farm. Five children were born to them as follows: Obe, Prettyman Wood, Ward, Velma, and Ezra. III. John Julian Marvel, the third child of George Rogers, and Sarah H. (McReynolds) Marvel, was born in Gibson County, Ind., December 7, 1840. He was a soldier in the Union Army, and died at his father's home in Franklin County before the end of the war of fever contracted while in the army.

IV. Wiley Hensley Marvel, the fourth child of George Rogers and Sarah H. (McReynolds) Marvel was born in Gibson County, Indiana, February 23, 1843. When about ten years of age he came with his parents to Franklin County, Illinois. He assisted his father on the farm until 1862, when he enlisted in the Union Army, Co. B.

of the 89th Illinois Regiment. He served until the close of the war, and was in twenty-one battles while in the service. After his discharge he returned home and on February 6, 1866, was married at the home of Mr. and Mrs. Alex McCreary, to Mary E. Herrill, who was born in Franklin County, Illinois, April 20, 1846. Her parents died when she was quite young and she made her home with her uncle and aunt, Mr. and Mrs. McCreary, until her marriage. They went to housekeeping on a farm which they owned in Williamson County, but later sold this and bought in Franklin County. They remained here until their children were all grown and married, when they disposed of the farm and moved to Benton, Illinois, where they still reside. Eight children were born to them as follows: Ella, Annie, William L. Ollie, John J., Charles H., Ida, Helen, Clyde.

- 1. Ella Marvel was born March 13, 1867. She was married April 8, 1885 to Warren Swain, a farmer, who was born in Christian County, Kentucky, February 14, 1861. They moved to Missouri in 1904 from the town of Marion, Illinois, and are now keeping a boarding house at Poplar Bluff, Missouri at 332 Bartlet Ave. Two children were born to them as follows: William A. and Mae.
- 1. William A. Weaver was born in Thompsonville, Illinois, October 25, 1877, and is now the foreman of a large mill company in Poplar Bluff, Missouri, residence ,East 124th Street. Hattie M. Marvel Stevens, the youngest and only living child resides at her home, 404 W. Webster Ave., in Benton, Ill., She is 71 years old, and of the five children born to her three are now living, namely: Mrs. Carl Rainey of Phoenix, Arizona; Raymond Stevens of Benton, Ill., and Jesse M. Stevens, of Benton, Ill.
