All land whereon I now live and my part of a mill on Bridge Branch and land in Caroline county adj. land belonging to heirs of Henry Ricards containing 50 acres, to my daughter Eliza Ricards unless my wife should have a child in nine months after my death. To uncle Charles Ricards a horse. Ex: wife Nancy. Wits: Levin Ricards, Esther Wright, Nancy Ricards.

Page 24. Neal, John, Sussex Co., Will made: 5 April 1802. Proved: 9 August 1803. To wife Prissilla Neal one third part of my moveable estate during widowhood. To son Charles Neal, 5 shillings. To son John Neal plantation known as Johns Folly (125 acres); and 5 shillings. To daughter Kettarah, wife of Jeremiah Dawson, 5 shillings. To son William Neal 100 acres called Curtissey. To daughter Margarett Neal (youngest daughter), 5 shillings. To son Henry Neal the plantation where

Jeremiah Dawson now lives that I bought of Peter Rust containing 148 ½ acres called Addition to Grapevine Thickett or Hard Fortune. To son Skinner Neal the plantation where John Elliott James now lives the same place I purchased of John Tull, 264 1/4 acres called by different names, part of Cannons Regulation, Neighbour Agreement and Cut Close and one horse. Land where Charles now lives to children: Charles, Kitturah and Margaret, 80 ½ acres called Addition to Four Tracts, Ex: John Neal. Wits: Richard Vickers, William Neal, Kissey Willing. Priscilla Neal renounced the will.

Page 28. Martin, John. Lewes and Reheboth Hundreds. Will made: 26 April 1802. Proved: 25 May 1802. Heirs: wife Lydia one third of all my estate during her life and after her death to my children Jonathan, Ruth, and James F. Martin. Other two thirds of estate to be equally divided among children. Ex: wife Lydia and brothers Josiah and James Martin. Wits: Robert Hunter, Amelia Coulter, Thomas Coulter.

Page 30. Riley, William. Will made: 22 December 1801. Proved: 30 December 1801. Heirs: wife Elizabeth one half of all my plantation and tenements; brother Laurence Riley one fourth of my plantation and tenements; brothers Johnson and Gabriel Riley one fourth of my plantation and tenements. Ex: brother Laurence Riley. Wits: Laben Carpenter, William Baker, Nancy O. Gabee.

Page 32. Bloodworth, William. Will made: 9 March 1802. Proved: 2 April 1802. Heirs: wife Betsy all my lands. Wits: Sarah Deen, Joshua McDaniel, James Weatherly.

Page 33. Marvel, Comfort. Will made: 20 September 1800. Proved: 9 March 1802. To son Phillip Marvel, all the cyder casks. To granddaughter Elon Burcher, bed and furniture, to be in the care of her guardian til she comes of age. After payment of debts the residue of estate to my two daughters Mary Marvel and Chloe Marvel and grandaughter Elen Burcher. Mentions granddaughter Comfort Burcher. Ex: son Adam Marvel. Wits: Thomas Marvel, Aaron Marvel.

Page 34. Harts, John. Will made: 27 October 1801. Proved: 30 October 1801. Heirs: Money and crop of corn to be equally divided between mother and brothers and sisters; brother James Hart; Zack Hart; Elizabeth Hart; Hessey Hart; Amelia

Page 310. Pool, Andrew. Will made 2 January 1803. Heirs: David West, son of Avery West to have all my land in Indian River Hundred; Sarah McIntosh West and Arcada West. Ex. Avery West. Wits. David Hazzzard Jr., Seleck Hazzzard.

Page 311. Marvel, Thomas. Will made 28 January 1797. Proved 15 December 1801. Heirs: son Thomas Marvel the parcel of land he now lives on; son Joseph Marvel land whereon son Parker Marvel has his plantation; son Robert Marvel; daughter Patience Marvel; son Obadiah Marvel; son Stephen Marvel; son Elisha Marvel; son Eli Marvel; Ex. son Joseph Marvel. Heirs: wife Rachel my plantation except part of my plantation that lies between the county road and where my son Wingate West lived; son John West to have same when wife dies or marries and other land mentioned; wife two Negro women Ginny and Sall; son Thomas West Negro woman Patience and two of her children Leah and Sall; son Philip West Negro lad Levin and Negro girl Rodah; daughter Levina Phillips, married woman, Negro girl Kisnah; son John West Negro boy called Isaac and Negro girl Alce; son John West Negro boy called James and Negro boy loshua; eldest Negro woman Dinah should have a place of abode on my plantation as long as she lives; grandchildren Wingate and Thomas West. Jordan Hall all that part of Elishas Lot; wife Comfort ½ of land Elishas Lott during her lifetime and to have a comfortable house built; son Caleb Rickards the other half of Elishas Lot; son Elijah Rickards; son Annanias Rickards; son George Rickards. Ex. son George Rickards. Wits. Wm. Jon. Hall, John Derickson, Levin Hill.
