Following is a listing of all the family members, lineage members and their spouses, that are known to have served in the military. Undoubtedly, many are not identified and many have been identified without sufficient detail to the honor they deserve.

This Honor Roll is sorted according to the family code.

Logan E. Knowles (1826-1877) [61311-(10)] Logan was a member of the United States Army during the Civil War. According to the Illinois Adjutant General's Report, Vol. IV, p. 567, Logan Knoles, from Sweetwater, Illinois, enlisted on August 9, 1862 in Company F, Seventy-third Infantry Regiment. The regiment participated in the Battle of Perryville, Kentucky. He received a disability discharge on October 22, 1863.

Lawrence Alby Knowles (1897-1989) [61311-(10)97] Lawrence was a member of the United States Army during World War I. He served from August 1918 to December 1918.

Thomas Wilbur Carothers (1920-1988) [61311-(10)972] Thomas was a member of the United States Navy during World War II.

William Franklin Knowles (1925-) [61311-(10)973] William was a member of the United States Navy during World War II. He served from 1942 to 1946.

Robert Lawrence Knowles (1927-) [61311-(10)974] Robert was a member of the United States Navy during World War II. He served from January 1946 to December 1947.

David Lawrence Knowles (1955-) [61311-(10)9742] David was a member of the United States Air Force. He chose the military as a career in 1978, he was a attorney and held the rank of Major.

Martin VanBuren Knoles (1844-1917) [61321-74] Martin was a member of the United States Army during the Civil War. According to the Illinois Adjutant General's Report, Vol. VII, p. 368, Martin B. Knoles from Sweetwater, Illinois enlisted in Company B, 152nd Regiment on February 4, 1865 and was mustered out, as a private, on September, 11, 1865. Prettyman Knoles and Joseph N. Knoles enlisted and were mustered out on the same dates.

John Martin Knoles, Jr. (1925-1963) [61321-74531] John was a member of the United States Army during World War II. John served as a medic - army was assumed.

Freddie Daniel Knoles (1928-) [61321-74533] Freddie was a member of the United States Army during the Korean War. Marvel Genealogy Military Honor Roll Robert Edward Knoles (1932-) [61321-74534] Robert was a member of the United States Air Force during the Korean War. He served in the Pusan area. Jake Willard Knoles (1916-) [61321-7458] Jake was a member of the United States Army during World War II. Arlin Bernice Knoles (1919-) [61321-7459] Arlin was a member of the United States Army during World War II. He became a prisoner of war. Claude Carroll Knoles (1914-) [61321-7811] Claude was a member of the United States Navy during World War II. He enter the Navy on February 21, 1933 and was discharged on February 20, 1937. During this time he was assigned to the United States Ship Colorado, a battleship, spending one year in the Atlantic and the remainder of the time in the Pacific. He reentered the Navy on September 10, 1943 and was assigned to the United States Ship ROI, an escort carrier assigned to the Pacific theater specifically in the area of the Admiralty, Mariana, and Marshall Islands and at Tokyo. He was a Petty Officer First Class when discharged on November 23, 1945. Walt Dannenberger (1923-) [61321-78111] Walt was a member of the United States Marine Corp during World War II. Rudolf Eckert (1972-) [61321-78111-1] Rudolf was a member of the United States Marine Corp. Claude Hart Knoles (1922-) [61321-7823] Claude was a member of the United States Army during World War II. He enlisted in the 106th Horse Calvary National Guard of Illinois on May 16, 1939. In 1940 the Guard was inducted into Federal Service and the 106th was renamed the 23d Recon. squadron and mechanized into Scout cars instead of the horses. In 1942 Claude took the Aviation Cadet examination for pilot training and was accepted into class 43F with pre-flight training at Randolph and Kelly Field Texas. He was a radio instructor for B29 combat crews at Geneva, Nebraska. He received an honorable discharge on December 7, 1946. James Russell Jarrett (1897-) [61327-2121] James was a member of the United States Army during World War I. He volunteered for service in the army. John Marvel (1794-1876) [61331] John was a member of the United States Army during the War of 1812. He volunteered for duty at seventeen years of age and was stationed at Vincennes, Indiana to guard the town. [61331-12]

## John McFadden McReynolds (1840-1887)

John was a member of the United States Army during the Civil War. In 1865, he responded to a call for volunteers and served in Company F, 110th Illinois Volunteers. According to the Adjutant General's Report his record was the same as his brother James except no discharge dated was given instead the statement "ordered to be discharged" was recorded.

# James Franklin McReynolds (1843-1868)

James was a member of the US during the Civil War. The Illinois Adjutant General's report shows that a James McReynolds from Franklin County, Illinois was mustered in on September 11, 1862. He entered Company A, 110th Illinois Regiment and was transferred to Company C (Consolidated). He was mustered out on June 8, 1865. The Regiment was assigned to 4th Division under General William Sooy Smith. It was in reserve at Perryville, was active at Danville on October 11, at Mt. Vernon on October 16, at Lavergne on December 26, and at Stone River on December 31 where they suffered heavy losses. Later they were active at Chickamauga, Missionary Ridge, Atlanta, and Sherman's "March to the Sea." They participated in the Grand Review in Washington, DC on May 24, 1865.

## John Wesley McReynolds (1881-

John was a member of the United States Army. John enlisted in the United States Army, Company E of the Eleventh Illinois Volunteer Infantry on December 19, 1901. He served in the Philippine War. He reenlisted in the Twenty-second Illinois Volunteer Infantry and was raised to corporal in October 26, 1904 and to sergeant on July 11, 1905. He was discharged on February 5, 1907.

Ellis was a member of the United States Navy.

#### Carol Layn Marvel (1933-

Carol was a member of the United States Navy during the Korean War. He enlisted in the Navy in February, 1953 at Bonham, Texas. He got sea duty almost immediately and served on the USS Manchester CL 83, until she was decommissioned in June, 1956. He was a ship serviceman 3rd class. While on this ship he had the opportunity to be an honor guard for the Unknown Sailor and received a special commendation for this service. Other ships he was on were the USS Everett F. Larson, the USS Hector AR 7, the USS George A. Johnson DE 583, the USS Spangler DE 696, and the USS General J. C. Breckenridge TAP 176. During the Korean War he took part in the Formosa Patrol and was in secret service missions to China. He was discharged the first time in February, 1957 after which he reenlisted for a second hitch. He was discharged March 18, 1961.

## John Edwin Marvel (1966-

John was a member of the United States Marine Corp. He joined the US Marines while in high school. He served at Fort Pendleton, California, at Norfolk, Virginia and in Okinawa. He was a lance corporal when discharged in 1988.

#### Kelley Marie Burley (1968- )

Kelley was a member of the United States Marine Corp. She served at Camp Pendleton where she met John. Kelley was a PFC when discharged.

#### Donald Jeffery Marvel (1972- )

Donald was a member of the United States Navy. He joined the Navy March 4, 1992. In 1993, he was a laboratory technician stationed in the base hospital at Yokosuka, Japan where he was to be stationed for two years.

#### Harold Layn Marvel (1935-

Harold was a member of the United States Navy during the Korean War. He left home at sixteen for San Diego, California to join the Navy. He served until his retirement having achieved the rank of Chief Warrant Officer.

## Linda Kay Potter (1960-)

Linda was a member of the United States Air Force. She served from June 12, 1979 through September 1, 1985.

#### Galen Craig Andrews (1960-)

Galen was a member of the United States Air Force. He was planning to retire in 1995 with over fifteen years of service.

## Christopher Thomas Ward (1970-)

Christopher was a member of the United States Marine Corp during Desert Storm. He served as a tow gunner and became a member of the Reserves.

## John Marvel (1827-1904)

John was a member of the United States Army during the Civil War. When the war started he volunteered and served for three years, then reenlisted and served to the end of the war. He served in the 42nd Indiana Infantry and was wounded at Stone River, Tennessee.

#### Baxter Halstead Wallace (1895-)

Baxter was a member of the United States Army during World War I. He was severely gassed. At the time of the writing of the M history he was in the Army Medical Corps Sternberg General Hospital, Manila, Philippine. He was almost completely recovered.

## George H. Cross ( -1926)

George was a member of the United States Army during the Civil War. According to the Illinois Adjutant General's Report, George H. Cross enlisted at Mattoon, Illinois in the 41st Illinois Infantry, Company K. He transferred to the Veteran's Battalion and then to Company K, 53rd Regiment, Illinois Infantry (Vol. III, pp. 203, 653). He served here from April 15, 1864 until he was mustered out on July 22, 1865. During this period of time Company F was in action at Allatoona Pass (fifteen miles north of Marietta, GA), in the siege of Atlanta, Georgia, where they suffered 101 causalities, and they pursued General Hood's forces after he surrendered Atlanta. They participated in Sherman's march to the sea including battles at Savannah and at Bentonville. After the war's end they were a part of the Grand Review in Washington, District of Columbia on May 24, 1865.

## Robert Montgomery (1798-1846)

Robert was a member of the United States Army during the War of 1812.

#### Prettyman Montgomery (1844-1862)

Prettyman was a member of the United States Army during the Civil War. According to the Illinois Adjutant General's Report, Vol. 5, p. 267, P. J. Montgomery, from Franklin County, Illinois enlisted in Company B, Eighty-ninth Infantry on August 13, 1862 and was mustered in on August 25, 1862. The Regiment was assigned to McCooks Corps and took an active part in the Battle of Stone River. He died in Nashville, TN on December 29, 1862.

#### William Aaron Montgomery ( - )

William was a member of the United States Army during World War I. He served seventeen months overseas with the 35 N. S. Engineers.

Sill, Oklahoma where Sergeant Kippert's connection with the Army was ended except for one year in the California National Guard at San Bernardino, California. Harold Baldwin ( - ) [61332-6242] Harold was a member of the United States Army during World War I. He was killed in service. Rollo Montgomery ( - ) [61332-634] Rollo was a member of the United States Army during World War I. Welzie Montgomery ( - ) [61332-635] Welzie was a member of the United States Army during World War I. Alvin Jasper Eaton (1887-) [61332 - 6(10)3]Alvin was a member of the United States Army during World War I. He served in France for six months. Wayne Taylor Montgomery (1895-) [61332-751] Wayne was a member of the United States Army. He was a member of Battery A, Provost Guard, Camp Jackson, South Carolina. William Hamilton Cline (1842-1906) [61333-21] William was a member of the United States Army during the Civil War. He was one of the first to respond to President Lincoln's call for volunteers for three months service and served for that time. Owing to poor health he was not permitted to re-enlist. Ralph Waldo Botkin (1882-) [61333-232] Ralph was a member of the United States Army during the Spanish-American War. He enlisted and served throughout the war. Richard Botkin Jones (1888-) [61333-246] Richard was a member of the United States Navy. He enlisted on January 24, 1907. He served on the United States Ship Tennessee, from 1907 to 1911, under Admiral Uriel Sebree. He was a Petty Officer Third Class when he was discharged in 1911. Earl Gilmore Levick (1895-) [61333-3122] Earl was a member of the United States Army during World War I. He enlisted as a musician. He was in a hospital in England when the Armistice was signed. Arthur E. Swan (1895-) [61333-3151] Arthur was a member of the United States Army during World War I. He entered the Army on May 20, 1918 and served in the 37th Infantry, Company M. He was stationed at Lorado and Camp Bowie, Fort Worth, Texas. He received an Honorable

They participated in Dakota Territory battles at Big Mound on 24 July, Stony Lake on 28 July, and at the Missouri River on 28-30 July. They were mustered out on 20 October 1963. On 18 February 1864, he enlisted in Union Army, Company C, 6th Minnesota Volunteers. He was mustered out on 19 August 1865. He served in the 147th Infantry Regiment from October 1945, until January 1947. [61334-21132] Russell E. Brundige (1940-) Russell was a member of the United States Air Force during the Vietnam War. The Regiment proceeded to Baton Rouge, Louisiana then they participated in the Red River Campaign. He was mustered out on May 10, 1865. **J. R. Grayson** (1927-) [61334-22211] J. was a member of the United States Navy. Maurice Beryl Shipley (1917-) [61334-2241] Maurice was a member of the United States Air Force during World War II. He enlisted in the United States Army then transferred to the Air Force. He retired in 1966. **Robert Eugene Shipley** (1923-) [61334-2244] Robert was a member of the United States Marine Corp during World War II. He served from March 1944 to May 1946. Edwin Francis Shipley, Jr. (1917-) [61334-2251] Edwin was a member of the United States Army during World War II. He was captured by the Japanese and was kept as a prisoner-of-war on the island of Java for some time. Douglas Bond Sexton (1920-) [61334-2861] Douglas was a member of the United States Navy during World War II. His service has not been recorded and was assumed to be the Navy. He had been in the service for about six months when he was lost over the Pacific. Joseph Marvel (1932-) [61334-2871] Joseph was a member of the United States Navy. He served from 1951 until 1953. Richard Douglas Marvel (1917-) [61334-2911] Richard was a member of the United States Army during World War II. He served from December 26, 1942 until December 25, 1946. Robert James Marvel (1919-) [61334-2912] Robert was a member of the United States Army during World War II. He served in the Medical Corps. Alexander M. Shafernich (1920-) [61334-2913] Alexander was a member of the United States Army during World War II. He was a captain in the Medical Corps. Orrie Bedell Marvel (1898-1962) [61334-294] Orrie was a member of the United States Army during World War I. He enlisted on April 9, 1917 during his senior year in high school. He was in the Argonne area when the Armistice was signed and was discharged in 1919. Laurence Roosevelt Marvel (1906- ) [61334-297] Laurence was a member of the United States Army during World War II. He served for two years. Dudley H. Riffe (1926-) [61334-2981] Dudley was a member of the United States Army during World War II. The service was not recorded and was assumed to be the Army. Stanley M. Riffe (1931-) [61334-2982] Stanley was a member of the United States Army. The service branch was not identified and was assumed to be the Army. Laurence W. Riffe (1935-) [61334-2983] Laurence was a member of the United States Army. The branch of service was not recorded and was assumed to be the Army. Lyall Howard Riffe (1935-) [61334-2984] Lyall was a member of the United States Army. The branch of service was not recorded and was assumed to be the Army. Glenn Moritmer Teal (1904-1943) [61334-3231] Glenn was a member of the United States Army during World War II. He served as an assistant professor of military science, with the rank of Major, teaching in the ROTC program. Stanton Teal (1930-) [61334-32311] Stanton was a member of the United States Army during the Korean War. He served from 1954 until 1955 spending most of the time in Korea.

He joined the Army Reserves; he was a Master Sergeant. James Henry Darden (1948-) [61334-32472] James was a member of the United States Army during the Vietnam War. He served from July 1968 to November 1976. He was a Staff Sergeant in the National Guard at Greenville, North Carolina. Steven C. Barr (1942-) [61334-32631] Steven was a member of the United States Air Force. He enlisted in August 1966. Dennis Barr (1947-) [61334-32634] Dennis was a member of the United States Air Force during the Vietnam War. He enlisted in 1966 and became an Air Traffic Controller. He was stationed in Germany and South Vietnam. Ronald Harold Heater ( - ) [61334-33222] Ronald was a member of the United States Navy. No additional information on his service experience was available.

He held positions of platoon leader and company commander while in Korea. He transferred to the Air Force in 1967. In 1990 he attained the rank of lieutenant general. See his biographical sketch for details of his impressive career. David Brian Teal (1965-) [61334-33311] David was a member of the United States Air Force during Desert Storm. He held the rank of first lieutenant in 1991. He was a navigator flying in KC-135 tankers. They refueled airplanes participating in Desert Storm. Raymond J. Collins (1926-1968) [61334-5425] Raymond was a member of the United States Navy during World War II. Russell C. Francis (1919-) [61334-5441] Russell was a member of the United States Army during World War II. George William Francis (1925-) [61334-5442] George was a member of the United States Navy during World War II. Russell Edward Dunlap (1970-) [61334-57122-1] Russell was a member of the United States Navy. He was stationed in Bethesda, Maryland. Ira Johnson Kemp (1921-1953) [61334-5714] Ira was a member of the United States Air Force during World War II. He served with the Eighth Air Force Command in England. Perry LeRoy Kemp (1923-) [61334-5715] Perry was a member of the United States Army during World War II. He served in Europe receiving the Purple Heart with Oak Leaf Cluster. Perry Roger Kemp (1949-) [61334-57151] Perry was a member of the United States Army during the Vietnam War. He returned from Vietnam in 1970 and was stationed at Fort Leonard Wood, Missouri. Franklin Crawford ( -1915) [61334-63] Franklin was a member of the United States Army during the Civil War. According to the Illinois Adjutant General's report Franklin Crawford, from Waynesville, Illinois was mustered into Company G of the Forty-first Illinois Volunteer Infantry on July 26, 1861. The Company was organized at Decatur, Illinois under the command of Colonel Pugh and was then assigned to General Prentiss who under the command of General C. F. Smith. The regiment was engaged at Fort Henry and at Fort Donelson where they were on the extreme right at the point where the Confederates attempted to cut their way out. The losses exceeded 200 men. At Shiloh they were assigned to General Hurlbut Division and came under fire for over six hours in the Hornets nest and the Peach Orchard, again their losses exceeded 200 men. They participated in the sieges of Corinth and Vicksburg. The Regiment was assigned to General McPherson and were engaged at Moon Station, Big Shanty, Marrietta, Kenesaw Mountain and Atlanta. McPherson was killed on July 22, 1864 and the Forty-first was selected to escort his body to his home. Franklin was discharged at the end of his three year enlistment on August 20, 1864.

#### George B Marvel (1918-)

George was a member of the United States Air Force during World War II. He enlisted in the Air Corps of the United States Army in February 1940 as a Flying Cadet. He graduated as a pilot and second lieutenant and was assigned to the Panama Canal Zone and arrived there one year before Pearl Harbor. He spent the next year flying patrol missions over the Pacific Ocean from Guatemala City. Three years later he was transferred to Kansas, returning to the Canal Zone in 1946. In 1949, he attended Air Command and Staff School and in 1952 he was assigned to Santiago, Chili. In 1955, he was sent to Chanute Air Force Base at Rantoul, Illinois and in 1960 he was assigned to Stead Air Force base in Reno, Nevada. He retired on July 31, 1961 as a Lieutenant Colonel. During his twenty-two years in the Air Force he had over 5000 hours of flight time in many types of aircraft including helicopters, amphibians, and jets with most of his time in four-engine aircraft.

## Keneth Barry Marvel (1943-)

Keneth was a member of the United States Air Force. He entered the United States Air Force on October 17, 1966 and was stationed at the Air Force Academy, Colorado Springs, Colorado until his transfer to Ankara, Turkey in 1969. He was a Captain in the Judge Advocate Branch of the Air Force. In 1994, Barry was a Colonel in the United States Air Force Reserve.

## Ronald Francis Baker (1940-)

Ronald was a member of the United States Air Force. Ronald stationed at Cambridge, England; Naples, Italy and at Clovis Air Force Base. He was Base Commander of Hollamah Air Force Base, Alamogordo, New Mexico when he retired as a Colonel.

#### Wiley Robert Marvel (1907-1975)

Wiley was a member of the United States Army during World War II. Wiley entered active duty on September 1, 1942 and attended Flight Surgeon training at Santa Anna Air Base, California and at Randolph Field, Texas. In May 1943 he was assigned to the 356th Fighter Squadron at Hamilton Field, California. On August 3, 1943 he was appointed Flight Surgeon. He departed the United States on October 17, 1943 and arrived in the China-Burma-India theatre on November 1, 1943. He was appointed Captain on April 1, 1944. He was assigned to the Headquarters Squadron until December 1944 then was transferred to the 72nd Air Service Squadron as Squadron Surgeon. He often talked about his "flying the Hump". American transports would take off from air fields in India carrying arms and supplies over the 15,000-foot Himalaya Mountains into southern China. Wiley expressed his pride in the dedication of these men who flew every day they could for eighteen months. In September 1945 he was assigned to the 88th Fighter Squadron. November 1, 1945 he departed for the United States and was discharged on January 20, 1946. Wiley was entitled to wear the American Theatre Campaign Ribbon and the Asiatic Pacific Theatre Campaign Ribbon with two Bronze Stars.

## Robert LeRoy Smith (1926-)

Robert was a member of the United States Navy during World War II. He enlisted in the Navy during his senior year in high school and received his call in August of 1944. He became 727-71-82 Robert (none) Smith. He received technical training at NAS Jacksonville, Florida, and at Norman, Oklahoma and flight training on the PBM at NAS Brownsville, Texas. He was awarded flight-crew wings and the rank of Aviation Ordnance Man 3/c. He was assigned to Squadron VPB-98 at NAS North Island, San Diego. The squadron was disbanded in January 1946 and he

Due to a mixup of military orders, he and about fifty other enlistees from the Grand Island area were placed aboard the United States Ship Argentina at Brooklyn Navy Yard on January 21, 1942. This occurred despite the fact they had only twenty-one days of service with only ten days being devoted to basic military training. They were united on board with the Thirteenth Reconnaissance Squadron and departed the United States on January 23. They arrived in Melbourne, Australia on February 26 and were assigned to the Royal Australian Air Force base nearby. Here he received training in aircraft radio operation, maintenance and aerial gunnery. This training was provided by a cadre from the Thirteenth Reconnaissance but was very minimal due to the lack of sufficient training devices. In August 1942 the unit was assigned to the Forty-third Bombardment Group which had arrived in northern Australia with aircraft and crews. Concurrent with this move the unit name was changed from the Thirteenth Reconnaissance to the 403rd Bomb Squadron. Charles was assigned to a combat crew as a radio and radar operator. He compiled forty-three missions and over 300 combat hours in the B-17 Flying Fortress and the B-24 Liberator over New Guinea, New Britain, New Ireland and the Solomon Islands. He was awarded the Silver Star, the Distinguished Flying Cross, and the Purple Heart for wounds received August 29, 1943 over Wewak, New Guinea. He received his discharge in 1945.

## William Michael Marvel (1946-)

William was a member of the United States Air Force. He graduated from the Air Force Academy, Colorado Springs, Colorado, with a Bachelor of Science degree in Engineering. On June 4, 1969, as a "Distinguished Graduate" he received his diploma from President Richard Nixon. On January 21, 1970 he received a Master of Science degree in Aeronautics and Astronautics from Purdue University, West Lafayette, Indiana. He was assigned to Vandenberg Air Force Base as Guidance Systems Engineer in the intelligence gathering and weather satellite missile program.

## Charles Patrick Marvel (1948-)

Charles was a member of the United States Navy during the Vietnam War. He enlisted in 1966 and was aboard the nuclear powered carrier Enterprise and survived the fires and explosions which occurred on January 14, 1969, near the Island of Kahoolwe, Hawaii. After the carrier was repaired in Pearl Harbor it entered the Vietnam conflict and participated in numerous air strikes before returning to the United States mainland in 1969. In January 1970, Charles was assigned to the carrier America and returning to the South China Sea, and to the Vietnam conflict.

Marvel Genealogy [61335-3] George William Fullerton (1823-1865) George was a member of the United States Army during the Mexican War. He served in both the Mexican War and Civil War. According to the Illinois Adjutant General's Report, Vol. I, p. 586, William Fullerton from Newark, Illinois enlisted in Company E, Thirteenth Illinois Infantry on May 24, 1861 and was mustered in the same day. He transferred to the In. (Indiana ?) Corps on September 20, 1863. The Regiment was stationed at Rolla, Missouri until the spring of 1862. They became known as "Fremont's Grey Hounds" after they marched forty-two miles in one day. They were in General Grant's Army that crossed the Mississippi at Grand Bluff. They participated in the capture of Jackson and were on the right during the siege of Vicksburg. They were stationed at Memphis and fought their way to Chattanooga to deliver General Sherman to his new command. [61335-4] William Knowles Marvel (1836-1914) William was a member of the United States Army during the Civil War. He served in Company F, 80th Regiment, 2nd Volunteers. [61335-63113] Keith Eugene Marvel (1955-) Keith was a member of the US Air Force. He was stationed in Ramstien, Germany. [61336-25121-2] Leslie De Ment Williams (1952-) Leslie was a member of the US Air Force. He graduated from Illinois State University and from Northwestern University School of Dentistry. He enlisted and has been stationed in Korea and Italy and had acheived the rank of Major. [61336-5513] Jonathon Godby Marvel (1950-) Jonathon was a member of the United States Army. He was a linguist, serving in Germany and the Netherlands for seven years. [61336-554] Charles Benjamin Wolf ( -1989) Charles was a member of the United States Army during World War II. He was a first Sergeant and was stationed in Australia. [61336-5611] Ronald Harold Stephan ( -) Ronald was a member of the United States Air Force during World War II. He was stationed in Germany for eight years. [61336-5(10)32]Reuben W. Dennis (1938-Reuben was a member of the United States Navy. He served for fourteen years. [61336-5(10)323]Katherina Magdelena Stumpe (1965-) Katherina was a member of the United States Army. She served for four years then joined the National Guard. [61336-5(10)521]Derek Wayne Stewart (1963-) Derek was a member of the US Army. In 1994, he was stationed in Germany. [61336-6422] Charles Everett Mitchell (1928-1984) Charles was a member of the United States Navy. He served for two years. [61336-6451] Bradford Ronald Stanerson (1933-)

Bradford was a member of the United States Navy. He entered the service on July 14, 1952 and was assigned to Naval Station at Bainbridge, Maryland for boot camp. After this he was assigned to the Bethesda Naval Hospital as a Naval

## Arnold Jerome Flagel (1934- )

Arnold was a member of the United States Navy. He was a Naval Corpsman; he was discharge in 1956.

#### Arthur E. Swan (1895-)

Arthur was a member of the United States Army during World War I. He served in Company M, 37th Infantry. He was discharged in March 1919.

#### Virgil Clair Marvel (1910-1989)

Virgil was a member of the United States Navy during World War II. He entered the Navy in 1943 and served on the United States Ship Minneapolis, in the South Pacific, until 1945.

## Ellery Everett Marvel (1922-)

Ellery was a member of the United States Marine Corp during World War II. He enlisted on September 29, 1942 serving with the First Marine Division in the South Pacific from March 12, 1943 to November 1, 1945. He participated in: the defense of New Guinea from November 9 through December 19, 1943; the action at Cape Gloucester, New Britain from December 26, 1943 (D day) to March 1, 1944; the defense of New Britain from March 6 to March 15, 1944; in action (commanded by Chester Puller) at Peleliu September 15, through October 14, 1944 and at Okinawa April 1, (D day) through August 15, 1945. He was awarded the Bronze Star for taking an artillery gun up a hill in front of the Japanese lines on Cape Gloucester. The following account, "Suicide Creek" was written by Sergeant Asa Bordages and published in the May 26 and June 2, 1945 issues of Collier's. The Marines were attacking Aogiri Ridge on January 8, 1944. "Meanwhile, (Lt. Col Lewis W.) Walt had called back for a 37-mm. fieldpiece. It was held up back in the jungle somewhere behind the battalion until an artilleryman from the 11th Marines said he might get the gun through with a caterpillar tractor. There was only one way he could go. For fifty yards or more that way ran right along the front line. It was through heavy mud; slow going. And he would be completely exposed to the enemy's fire. They told him that but Pfc. Ellery Everett Marvell said he'd give it a go. The battle was at a furious pitch as he came clattering along the front, perched high on the driver's seat of the tractor, perched like a hen on a roost, the plainest target a man could have, with the whole enemy line blazing at him. Bullets banged on the cat, on the gun, and bullets hit within inches of him, but by crazy luck "that marvel Marvell" wasn't hit. He swung in at last at battalion headquarters. He lighted a cigarette. "Here it is" he said. "Where do you want her?" They told him the spot on the line. He said "Okay" and trundled off to deliver the gun. Then he swung homeward. They figured he was a dead man for sure. He'd made it once, a million-to-one shot, and at those odds you don't repeat. Again bullets banged and clattered against the ambling cat. Hundreds of bullets spitting past the driver's head. But the long shot came through again. It was plain impossible, but he didn't get a scratch." He was discharged on November 10, 1945, as a Private First Class his rate of pay was fifty-six dollars and thirty-five cents a month.

## George W. McReynolds (1841-1865)

George was a member of the Confederate Army during the Civil War. He was a Texas Ranger prior to the war. He served in the Gano's Division, Girley's Division, 30th Calvary; he was killed near Cow Creek, Oklahoma.

#### George Rogers Marvel (1815-1889)

George was a member of the United States Army during the Civil War. According to the Illinois Adjutant General's Report Vol. 8, p. 485 George R. Marvel enlisted, as a ferrier, in Company C, Fifteenth Cavalry on August 10, 1861. The Regiment was under the command of, his friend, General John Logan. It participated in the battles of Belmont, Fort Henry, Fort Donelson, Shiloh, Cornith, Oxford, Holly Springs, Champion Hill, Black River, Raymond, and Vicksburg plus numerous skirmishes. Because of his rheumatism and deafness he resigned and was discharged from Company C on April 10, 1863. Logan dispatched him to raise a Regiment of 1000 men but he ultimately raised 13,000 men which were organized into the Thirteenth Illinois Calvary. Per the Report, he reenlisted on February 12, 1864 as a Colonel and was discharged on April 11, 1864.

## Prettyman Wood Marvel (1839-1926)

Prettyman was a member of the United States Army during the Civil War. According to one account, shortly after his marriage he enlisted in the Sixth Illinois Calvary, where he served throughout the war. According to the Adjutant General's Report Vol. VIII, p. 24, Prettyman W. Marrell [sic], from Dillon, Illinois enlisted and was mustered in on March 10, 1865 to Company F, Sixth Illinois Calvary. He was mustered out on November 5, 1865. The Sixth Illinois was one of three Regiments that were led, in 1863, by Colonel Benjamin H. Grierson on the famous raid from LaGrange, Tennessee to Baton Rouge, Louisiana.

William Lee Marvel (1936-)

William was a member of the United States Air Force. William entered the service in 1955. He was a A/2c.

#### James Frank Marvel (1937-1963)

James was a member of the United States Navy. James served was a member of the crew of the United States Ship Sea Dragon when it met another submarine under the North Pole. At the time of his death he was travelling to join the United States Ship Daniel Boone. He served for six years.

## Prettyman Wood Johnson (1895-1980)

Prettyman was a member of the United States Army during World War I. He served in France.

#### Dwight Zois Johnson (1921-)

Dwight was a member of the United States Army during World War II. Army was assumed.

## Beler Huy Watts, III (1965-) [61339-27211-2] Beler was a member of the United States Army during Desert Storm. He was a

## Anita Luisa Seneres (1965- )

The Illinois Adjutant General's Report Vol. VII, p. 77, lists a John Marvel from Fairfield, Illinois that enlisted in Company C, One Hundred Thirty-sixth Illinois Infantry on May 19, 1864 and was mustered out on October 22, 1864. During this time the Regiment chased Forrest's Cavalry in Kentucky and TN and then were sent to St, Louis to meet the Confederate forces of General Price. He died of a fever contracted while in the Army.

#### Wiley Hensley Marvel (1843-1924)

Wiley was a member of the United States Army during the Civil War. According to the Adjutant Generals Report, Volume V, page 267 he was mustered in on August 13, 1862. He became a member of Company B of the Eighty-ninth Illinois Regiment. It was known as the Rail Road Regiment. They saw action in twenty-one battles including Perryville, Stones River, Chickamauga, Lookout Mountain, Missionary Ridge, Kennesaw Mountain, Atlanta, Franklin, and Nashville. Of the 1403 men who entered the Regiment a total of 820 were either killed in action, died from wounds or died on account of a disability contracted in the service. Wiley was a member of the Regiment from organization to dissolution. He was a Corporal when mustered out on June 10, 1865.

#### William Teal Marvel (1845-)

William was a member of the United States Army during the Civil War. According to the Illinois Adjutant General's Report Vol. VIII, p. 446, William T. Marvel from Franklin County, Illinois enlisted in Company K, Thirteenth Consolidated Cavalry, on February 29, 1864 and was mustered in on March 26, 1864. He died at Pine Bluff Arkansas on September 7, 1864.

#### -1944) James Stevens (

[61339 - (12)123]James was a member of the United States Marine Corp during World War II. He was killed on Saipan.

#### Reuben Joshua Marvel, Jr. (1909-)

Reuben was a member of the United States Navy during World War II. His career in the United States Navy started in 1932 and ran until December of 1954. He left pre-med school with the intent to serve one hitch as a pharmacist's mate. Things had not improved by 1936 so he reenlisted as an electrician's mate. He

came home from the Philippines in 1941 just before Pearl Harbor and was recalled for service through the war. At the end of World War II he had achieved the rank of chief warrant officer and decided to remain in the Navy. He served chiefly on submarines and subtenders, though during the 1930's he spent several years aboard gunboats and the battleship New Mexico in China and the Philippines. After the war he worked at the Norfolk and Portsmouth shipyards where he supervised much of the electrical construction aboard the first nuclear sub, the Nautilus.

#### William Marvel (1949-)

William was a member of the United States Army during the Vietnam War. He served from 1968 to 1970.

#### Robert Marvel (1916-)

Robert was a member of the United States Navy during World War II. He served as an officer from 1942 to 1965.

#### Paul Olin Still (1911-1975)

Paul was a member of the United States Navy during World War II. He enlisted in the Seabees and served in the Pacific theater. He contracted hepatitis while in the service. He died of cancer of the liver.

## Paul Olin Still, Jr. (1939-)

Paul was a member of the United States Navy. He served for six years including a tour of duty on the nuclear powered submarine United States Ship Redfin.

#### John B. Marvel (1832-1863)

John was a member of the Confederate Army during the Civil War. John enlisted on July 3, 1862, he died in a hospital at Little Rock, Arkansas on March 1, 1863.

#### Ephriam Roger Marvel (1896-1956)

Ephriam was a member of the United States Army during World War I.

#### Frederick Arthur Moore (1918-)

Frederick was a member of the United States Air Force during World War II. He served in the Signal Corps.

#### Philip Marvel (1779-1851)

Philip was a member of the United States Army during the War of 1812. He was a Captain.

Cloyd Everett Irons (1892-1897) [61691-462] Cloyd was a member of the United States Army during World War I. He left for camp on June 24, 1918. Frank Pilgrim ( - ) [61691-471] Frank was a member of the United States Army during World War I. He left home for the service on June 24, 1918. He was overseas when his daughter was born, March 19, 1919. Orie E. Davis (-) [61691-472] Orie was a member of the United States Army during World War I. He left for service on June 24, 1918. John Bales ( - ) [61691-5] John was a member of the Confederate Army during the Civil War. Being in the South at the beginning of the Civil War John was obliged to serve in the Confederate Army, which meant he was fighting against his wife's brothers. He was twice taken prisoner by the Union Army and was once held in Chicago. When released after the war he had to walk most of the way to Alvarado, Texas where his family was. Robert Marvel (1837-) [61691-6] Robert was a member of the United States Army during the Civil War. He received a serious wound during the war and carried the affliction the remainder of his life. According to the Illinois Adjutant General's Report Robert Marvel from Joshua, Illinois enlisted in Company C, one hundred third Illinois Infantry on August 12, 1862 and was mustered in on October 2, 1862, He was given a disability discharge on January 19, 1863. Samuel Marvel (1842-1864) [61691-8] Samuel was a member of the United States Army during the Civil War. Samuel was a member of Company I, Thirteenth Regiment, Iowa Infantry. He carried a musket while his brother, Samuel, was a drummer boy. After battles it was their custom to look for each other. After the Battle of Atlanta, Georgia on July 22, 1964,

Samuel was not found. It was always the supposition that the Confederates had gathered him with their dead and buried him. This was the same day that General James B. McPherson was killed.

## Francis Marvel (1844-1917)

Francis was a member of the United States Army during the Civil War. He enlisted in Washington County, Iowa as a member of Company I, Thirteenth Regiment, Iowa Infantry. He was a little less than seventeen years of age when he enlisted and served throughout the war, three years and eight months, as a drummer boy. He was in some of the hardest battles of the war including Shiloh, Cornith, Vicksburg, and Atlanta plus he was on Sherman's march to the sea. After the war he never worked on July 22 as that was the day of his mother's birth and his brother's death.

## Lewis Cass Marvel (1848-1912)

Lewis was a member of the United States Army during the Civil War. He enlisted when he was seventeen years of age. He served under Randolph Fry in Company G, Fourth Iowa Infantry Veteran Volunteer Regiment. The effective date of his enlistment was February 1, 1865, service to be for one year or the close of the war. The war ended in April and he was discharged from service in July 1865 at Louisville, Kentucky.

## Walter Charles Marvel (1898-1954)

Walter was a member of the United States Army during World War I. He was in training at the University of Illinois; he was scheduled to board an army troop ship to go to the frontier in Siberia to help defeat the Germans when the war ended.

## Horace Daniel Marvel (1923-

Horace was a member of the United States Navy during World War II. He enlisted in 1942 and attended Eureka College, Illinois State Normal and Columbia University in New York. He was made a Yeoman 2/c and served in the Pacific Theater of War on board the USS LSM 495. They were at Guam, scheduled to participate in the invasion of Japan, when the war ended.
